EJEFFERSONVILLE POOL SAFETY STANDARDS RESIDENTIAL ABOVE AND IN-GROUND

DATE

In accordance with the Indiana Swimming Pool Code, the following safety features are required for all residential swimming pools installed after April 25, 2011, that have a capable water depth of more than 42 inches:

L ACCESS TO RESIDENTIAL POOLS SHALL BE RESTRICTED BY ONE OF THE FOLLOWING MEANS:

- A. Walls or fencing not less than 4 feet high and completely surrounding the pool and deck area, with the exception of self-closing and latching gates and doors capable of being locked.
- B. Other means not less than 4 feet high and deemed impenetrable by the enforcing authority at the time of construction and completely surrounding the pool and deck area when the pool is not in use.
- C. A combination of clauses A and B that completely surrounds the pool and deck with the exception of self-closing and latching gates and doors which are capable of being locked. This applies to clauses A and B and this clause only.
 - D. A power safety pool cover that:
- Provides a continuous connection between the cover and the deck, so as to prohibit access to the pool when the cover is completely drawn over the pool.
- Is mechanically operated so that the cover cannot be drawn open or retracted without the use of a key — or switch and key — or touch pad with a personal code.
- Is installed with track, rollers, rails, guides or other accessories necessary to accomplish items in the two aforementioned safety points and in accordance with the manufacturer's instructions; AND
- Bears an identification tag indicating that the cover satisfies the requirements of ASTM F1346-19 (re-approved in 2003), Standards Performance Specification for Safety Covers and Labeling Requirements for All Covers for Swimming Pools, Spas and Hot Tubs as published by ASTM International.

II. EVERY RESIDENTIAL SWIMMING POOL MUST BE INSTALLED WITH NO LESS THAN THE FOLLOWING LIFESAVING EQUIPMENT:

- A. A ring or throwing buoy fitted with 40 feet of 1/4-inch diameter line.
- B. A pole not less than 12 feet in length.
- C. Access to a telephone.

JII. THE ELECTRICAL SERVICE TO EVERY RESIDENTIAL SWIMMING POOL MUST BE IN ACCORDANCE WITH THE 2008 INDIANA ELECTRICAL CODE.

- A. The power supply must be connected to a ground fault interrupter circuit (GFIC). No extension cords may be used.
 - B. No pool shall be installed below overhead or above undergound electrical wires.
 - C. An electrical permit will be required for any new permanent electrical connection, devices or wiring.

IV. ADEQUATE SITE DRAINAGE SHALL BE PROVIDED SO AS NOT TO CREATE A HAZZARD OR NUISANCE.
